**SUBJECT : Tenth Supplement to Executive Order (EO) No. 20-018-
A, s. 2020**

WHEREAS, there is a need to supplement the aforementioned EO in view of the sudden surge of COVID-19 positive cases in the Province of Surigao del Norte, so as to manage and mitigate the spread of COVID-19 in the Province.

NOW THEREFORE, I, ATTY. FRANCISCO T. MATUGAS, Provincial Governor of the Province of Surigao del Norte, by virtue of the powers vested in me by law, do hereby order as follows:

1. All persons who will board cargo vessels going to Siargao Island, such as but not limited to truck drivers and their helpers shall present at the Eva Macapagal Passenger Terminal and at any ports in Siargao, a negative result of their Rapid Antibody Test taken within five (5) days prior to the date of departure;
2. All passenger trips going to and from the Port of Dapa in Dapa, Surigao del Norte, Port of Del Carmen in Del Carmen, Surigao del Norte, Port of Sta. Monica in Sta. Monica, Surigao del Norte, Port of San Benito in San Benito, Surigao del Norte, and Port of Socorro in Socorro, Surigao del Norte shall be temporarily suspended from 26 to 30 June 2020, due to the following reasons:
 - 2.1. In order to give way to the 2nd level contact tracing for close contacts of the 7th confirmed COVID-19 case of the Hindanganon (resident of Hindang, Leyte) Locally Stranded Individual from General Luna, Surigao del Norte; and

- 2.2. So as to focus our human resources in managing the twenty-three (23) Asymptomatic COVID-19 positive patients as well as the thirty-eight (38) Surigaonons who tested positive for Rapid Antibody Test.

All provisions of the prior Executive Orders and Memoranda issued by the undersigned inconsistent of the aforementioned orders are hereby AMENDED and/or MODIFIED accordingly.

This Order shall take effect on 26 until 30 June 2020.
