**AN ORDER CREATING THE PROVINCIAL COMMITTEE FOR THE
PROCUREMENT OF CORONAVIRUS DISEASE (COVID-19) VACCINE**

WHEREAS, our Province is still not free from the threat of COVID-19 which up to now causes death worldwide. Hence, there is now an urgent need to adopt certain additional measures to promote the health and safety of our people in accordance with **Section 16 of Republic Act No. 7160**, the **Local Government Code of the Philippines**;

WHEREAS, according to the medical experts, the only cure for COVID-19 is an appropriate vaccine, which is now available in the market but with limited supplies due to the high demand worldwide;

WHEREAS, there is now an urgent need for this Province to procure an appropriate vaccine against COVID-19 so as to protect our constituents and to boost our local economy to recover from the negative social and economic impact of the foregoing deadly disease.

NOW THEREFORE, I, ATTY. FRANCISCO T. MATUGAS, Provincial Governor, this Province, by virtue of the power vested in me by law, do hereby order as follows:

Section 1. Creation of PCPCV. The Provincial Committee for the Procurement of COVID-19 Vaccine (PCPCV) is hereby created with the following composition:

- Chairman : HON. EDDIE D. GOKIANGKEE, JR.
Provincial Vice Governor
- Vice-chairman : ATTY. ZANDER J. PLAZA, CPA
Provincial Legal Officer/Chief of Staff-PGO
- Members : 1. SIMEON VICENTE G. CASTRENCE
Assistant Provincial Administrator
2. MA. MYRLA S. PADAYHAG
Outsourced Financial Management Adviser

3. DR. ARLENE T. FELIZARTA
Asst. Provincial Administrator for Health and Hospital Concerns

Section 2. Role of PCPCV. The PCPCV shall have the following functions:

- a.) Facilitate procurement of COVID-19 vaccine through various mechanisms allowed under existing laws, rules and regulations through bilateral, multilateral, and other financial modalities;
- b.) Formulate "Provincial COVID-19 Vaccination Roadmap and Implementation Plan," which shall be in accordance with the national laws, rules and regulations; and
- c.) Do such other duties and responsibilities necessary to carry out the aforementioned functions.

Section 3. Convening of PCPCV. The PCPCV shall convene to carry out its functions after the issuance of this order, and shall have meetings as many as necessary thereafter.

Section 4. Repealing Clause. All provisions of prior orders, rules and regulations, other issuances or part thereof which are inconsistent with the provision/s of this order are hereby repealed or modified accordingly.

Section 5. Effectivity. This order shall take effect immediately.
