EXECUTIVE ORDER NO. 21- 011

AN ORDER INSTITUTIONALIZING THE "PAMILYA MO, PAMILYA KO PROGRAM" AS A MEDIUM FOR THE EFFECTIVE AND EFFICIENT DELIVERY OF "HEALS" SERVICES TO THE PEOPLE OF SURIGAO DEL NORTE ESPECIALLY DURING COVID-19 PANDEMIC

WHEREAS, it is the policy of the State to free the people from poverty through policies that provide adequate social services, deliver a rising a standard of living, promote full employment, and make available and improved quality of life for all;

WHEREAS, HEALS Program is the flagship program of the previous administration headed by Governor Sol F. Matugas which the current administration is continuing to implement. HEALS is the acronym for Health, Education & Environment, Agriculture & Aquaculture, Livelihood and Tourism and Social Services & Spirituality services of this Province;

WHEREAS, the HEALS Program focuses on the delivery of basic services to all Surigaonon concentrating in the Health sector, Education and Environment sector, Agriculture and Aquaculture sector, Livelihood sector, Spiritual Renewal, Security and Social Welfare;

WHEREAS, there is a need to effectively and efficiently deliver the HEALS services of this Provincial Government all the way to the homes of our constituents to address the negative impacts of COVID-19 pandemic while ensuring that the health protocols shall be followed so as to prevent and control the spread of the aforementioned deadly virus;

WHEREAS, through the "**PAMILYA MO, PAMILYA KO PROGRAM**," the process in the delivery of HEALS services all the way to the households in this Province shall be streamlined which would ensure compliance of health protocols as well, all for the best interest of our people.

NOW, THEREFORE, I, ATTY. FRANCISCO T. MATUGAS, Provincial Governor of Surigao del Norte, by virtue of the powers vested in me by the Constitution and the laws, do hereby order as follows:

Section 1. Institutionalization of "Pamilya Mo, Pamilya Ko Program."

In order to ensure effective and efficient delivery of the services of this Provincial Government all the way to the homes of Surigaonons on health, education, environment, agriculture & aquaculture, livelihood, tourism, social services and spirituality the same will be coursed through the "**Pamilya Mo, Pamilya Ko Program**" of this Province that is mainly managed by the Provincial Governor's Office and the Provincial Administrator's Office. Thus, the concerned divisions of the Provincial Governor's Office shall ensure that the delivery of the aforementioned services to the households of Surigao del Norte residents shall be streamlined with due consultation with provincial departments of this Provincial Government.

"An Surigaonon labaw sa tanan"

Section 2. Compliance of Health Protocols. The concerned personnel who are tasked to manage the "*Pamilya Mo, Pamilya Ko Program*" shall ensure compliance at all times of the national and local health protocols in the conduct of service delivery so as to avoid the transmission of COVID-19 from one person to another.

Section 3. Cooperation of Provincial Departments. To ensure the success of "*Pamilya Mo, Pamilya Ko Program*" for the best interest of Surigao del Norte residents, all the provincial departments of this Province are enjoined to give full support and cooperation to said program especially on the programs, projects and activities that need to be implemented efficiently to address the negative impacts of COVID-19 pandemic.

Section 4. Funding. All expenses to be incurred in the delivery of HEALS services to the people of Surigao del Norte through the "*Pamilya Mo, Pamilya Ko Program*" shall be charged against the pertinent available funds of this Provincial Government subject to the compliance of the usual accounting and auditing rules and regulations;


Section 5. Separability Clause. In the event that any provision of this order or any part thereof is declared invalid, illegal or unconstitutional, the provisions not hereby affected shall remain in force and effect.

Section 6. Repealing Clause. All orders, rules and regulations, other issuances or part thereof which are inconsistent with the provision/s of this Order are hereby repealed or modified accordingly.

Section 7. Effectivity. This order shall take effect immediately. This order may also be supplemented by the succeeding memoranda that shall be issued by the undersigned in order to address whatever developments that may happen thereafter.
